- iii. Should have valid PAN and GST registration. (Please provide self-certified copy of PAN card and GST registration certificate)
- iv. Should have average turnover of at least Rs. 10 Lakhsover three Financial Years, i.e. 2017-18, 2018-19 and 2019-20.
- v. The agency should have experienced and sufficient work force to be deployed for data collection and social impact assessment.
- vi. The agency should have technically qualified workforce comprising researchers, investigators, experts; at least one of them should be woman in the SIA team.
- vii. The agency should have operational area/supportcenters in Odisha and be able to provide Reports in English and Odia.
- viii. Agency should have undertaken study on its own and not through third party.
- ix. Application in respect of Agencies which are black listed (under declaration of ineligibility) by any State Government/Govt. of India for corrupt and fraudulent practices will not be entertained. A self-declaration certificate should be submitted as part of eligibility criteria.
