## Scope of Work:

- Routine corrective and preventive maintenance of the computer system and its peripherals as specified in the inventory of equipments to be covered under AMC.
- Software installation, un-installation, configuration, virus/malware removal, antivirus software upgradation, integration and maintenance to make the whole system/equipments/network fully functional.
- 3) Preventive maintenance of the whole computer system will be done on monthly basis which includes external/internal cleaning of the system/equipments, running diagnostics/utilities tools to determine the existing or likelihood faults and their removal.
